Explained that the CRSO is the one you have to send the form to.
- 2) Wood Frames for 1000 – Stan states they need pressure treated lumber and hardware. Mitch makes motion for 400.00 for the building of the target holders at the 1000 year. Jim Asks for it to be amended too500.00 for the taxes and other incidentals. Mitch remakes his motion to 500.00. Vicki seconds. Stated need to go to True Value to put it on the account instead of having it come out of the account unless necessary.
- 3) Dave Vance clays – Vicki brings up for the purchase of clays. Tabled Vicki. Farren Seconded.
- 4) Wood sign at the entrance – Craig working on the open closed sign for the front gate. Everything sounds good.
- 5) Only allowing membership to the Mohave county residents. Mitch brought up the thought of only allowing the residence of Mohave County to be members. Vicki and Jim explained about snowbird and others coming from like Colorado and Nevada
